***Transitional Housing:** One and two bedroom apartments.

***Transitional Living:** There is a two- year commitment, the individual must test clean from all substances, cannot have outside income initially, (Social Security beneficiaries may qualify though), potential participants cannot have past evictions for arson or sexual offenses. Faith based.

Process: Interested party must call for a phone intake. Administration will determine eligibility and provide directives. There is a one-year minimum commitment and all participants must be employable. Potential participants cannot have past evictions for arson or lewd acts with children. . If the participant is using substances, they will have to withdraw at the ranch with no medical attention. No Psychotropic or injectable medications allowed. Faith based.

Process: Interested party must call and complete a telephone intake. Director will review intake information and the potential client will be notified if they meet the criteria and room is available. Participants must be clean and sober, cannot be listed on the Megan's Law registry, have ever been arrested for crimes against children, or have committed sexual offenses. Participants must be med compliant if they have a diagnosed mental health condition. Project Touch has two programs:

Emergency Shelter: Women and children can stay up to 21 days free of charge.

Transitional/Shared Housing: Single individuals and families live in shared housing, costs range from \$420 for a single individual and up to \$750 for a large family per month.

Process: Interested party must call and complete a phone intake. There are two facilities, a men's and woman's facility. Participants must agree to an initial two-month stay, and then continue to the second phase if needed. No pain or psychotropic medications are permitted at the ranch. If the participant is using substances, they will have to withdraw at the ranch with no medical attention. Sexual offenders or arsonists will not be permitted to participate in the program. Faith based.

Process: Mandatory intakes for both men and women are held the first and third Wednesday of each month at 8 A.M. sharp. Interested party should arrive early and bring identification and their social security card if possible. Once the interview is complete, the potential client will be provided with a medical packet. A full physical including blood work and a TB test will be required (Interested party should obtain Medi-Cal or private insurance coverage). Once the information from the physical is received by the Teen Challenge administration, the potential client will be contacted. If approved, the client will either enter the program or be placed on a waiting list. The program is a mandatory one-year program. After successfully completing the first year, the client can opt for a four-month apprenticeship program. Clients with current substance abuse are advised to detox before entering the program, or will have to go through withdrawals in the program. Clients with mental health conditions will not be allowed to take medications while in the program. Sexual offenders must contact Teen Challenge- Watsonville @ (831)724-9576 for information on entering the program at that location. Faith based.
