**REGISTRATION: Taken first come first serve online and at the Lake Community Center**

**Early Bird Registration: April 16 – May 6 \$275**

**Regular Registration: May 7 – May 25 \$300**

**Late Registration: May 26 – May 31 \$325**

**Registration forms must be accompanied with the entry fee.**

**FEE: \$300 per team, this includes the umpire fees and game supplies.** You can pay by Visa, MasterCard, Discover, cash, or check payable to the City of Lake Elsinore. **Early Bird Registration \$275**  
**Late Registration Fee \$25**

**SEASON: Play begins Friday, June 1, 2018**

**LEAGUE FORMAT:** The league will use an 8.5” size kickball. Eight games guaranteed; eight game round robin division play followed by a one evening single elimination tournament. **A full team would consist of five men and five women.** A team can play a game with a minimum of eight players and a maximum of 13 players as long as the kicking order adheres to the alternating gender kicking rule. **LOCATIONS:** Summerly Park

**NIGHT OF PLAY:** Friday. (All dates and locations subject to change depending on number of registered teams and field availability.)

**GAME TIMES:** Game start times will be between 6:00 p.m. and 9:00 p.m. (As close to an even distribution of early and late game times will be provided).

**GAME LENGTH:** 6 Innings or 40 minutes, whichever comes first.

**PLAYER ELIGIBILITY:** All players must be 18 years of age at the time of their participation in the league. \*Max of 2 16-17 year olds per team with parent/guardian approval and waiver.

**FREE AGENTS:** Visit [lake-elsinore.org/adultsports](http://lake-elsinore.org/adultsports) to add your name to the free agent list. A free agent is an individual who wants to play and can't create their own team. There is no fee for us to place you on the free agent list. This list is provided to all managers of each team in our league. There is no guarantee that you will get on a team.

**MANAGERS MEETING: (Mandatory) – The managers meeting will be held at the Lake Community Center on TBD**

**ROSTERS:** There is a roster limit of 13 players. Players can play on only one team per season. Managers will be required to print and have players sign a game card prior to the start of each game. Failure to bring a game card could result in a team forfeit. **All players must sign the game card prior to the start of each game. Any player who fails to sign the game card will not be eligible to play.**

**WEATHER:** To find out if a scheduled game has been canceled or postponed due to inclement weather, visit [www.lake-elsinore.org/fields](http://www.lake-elsinore.org/fields). If a game is canceled, they will be rescheduled to the end of the season (if time permits). It is the manager's responsibility to find out when games are rescheduled.

**TOURNAMENT:** We will provide a single elimination tournament at the end of divisional play. Tournament information will be posted on the website at the end of the season.

**AWARDS:** The championship team will be awarded prizes at the conclusion of the season.
