



NOTICE INVITING BIDS

NOTICE IS HEREBY GIVEN that the City of Lake Elsinore, is accepting sealed Bids for a contract for construction of the Work generally described as: **SB 821 BICYCLE AND PEDESTRIAN FACILITIES PROGRAM - MACHADO STREET AND LAKESHORE DRIVE SIGNING & STRIPING PROJECT, CIP PROJECT NO. Z10051**

Bids will be publicly opened, examined and declared in the City Hall Conference Room A, 130 S. Main Street, Lake Elsinore, CA, on April 1, 2019, at 2:00 p.m.

SCOPE OF WORK. The project is funded by SB821 Grant and consists of bike lane striping, pavement markings, and traffic signage (5 sheets). Bid Items are listed under Bid Schedule. The Contractor shall be responsible for completion of all other items not mentioned above but indicated in the Plans and Specifications. Bidders for this project shall complete according to the plans and specifications all improvements listed on plans and/or specifications. **Bidder must be able to mobilize and commence construction activities within the fifteen (15) working days from the "Notice to Proceed" if selected**

Obtaining Bid Documents. Bidders may obtain the specifications documents through the City's website at www.lake-elsinore.org under the Bids/RFPs section or through PlanetBids (www.planetbids.com), **there will be a non-refundable charge of \$10.00.** Although the plans, specifications, and bid documents may be obtained from other electronic sources, including the City's website, **only the electronic documents downloaded directly from PlanetBids** will be considered to be **official** documents of the City of Lake Elsinore. Addenda will be delivered by email only to those that provide the required information to the City Engineer and PlanetBids.

All SEALED bids shall be submitted to the City Clerk no later than the above stated time, at the above referenced address. No facsimile bids shall be accepted by the City.

In compliance with SB 854, the City require contractors and subcontractors to be registered with the DIR prior to submitting a bid on any public works project. Bids from contractors or subcontractors that are not currently registered as required will be deemed nonresponsive, and no contractor or subcontractor will be allowed to work on a City project unless they are registered with the DIR pursuant to Labor Code Section 1725.5. This project is subject to compliance monitoring and enforcement by the Department of Industrial Relations.

BIDDING PROCESS. The City Council of the City of Lake Elsinore reserves the right to reject any or all bids, and/or waive any irregularities or informalities in any bid. No bidder may withdraw his bid for a period of sixty (60) days after the date set for the opening thereof. A full copy of this notice may be found on PlanetBids.
