

Project Applicant: City of Lake Elsinore

**Project Location:** The Project encompasses the entire City of Lake Elsinore, California and its Sphere of Influence, which are bordered by the Elsinore Mountains to the west, which is part of the Santa Ana Mountain Range. The City is surrounded by Wildomar to the southeast, unincorporated Riverside County to the west and north, and Menifee and Canyon Lake to the east. The City's planning area (including its sphere of influence) encompasses approximately 72 square miles.

**Project Description:** The project consists of three components consisting of:

- The adoption and implementation of the City of Lake Elsinore 2021-2029 Housing Element, which represents an update of the City's Housing Element.
- An update of the General Plan Safety Element contained in Chapter 3.0 (Public Safety and Welfare) of the City's General Plan pursuant to California Government Code Section 65302(g)(3).
- A new Environmental Justice Element, which is being incorporated into Chapter 3.0 pursuant to Government Code Section 65302 (h)(1).

This is to advise that the City of Lake Elsinore City Council as Lead Agency has approved the above project on August 23, 2022, and has made the following determinations regarding the above-described project:
