NOTICE IS HEREBY GIVEN that pursuant to California Elections Code § 10229 relating to the General Municipal Election in the City of Lake Elsinore to be held on Tuesday, November 5, 2024:

As of the close of the nomination period on August 9, 2024, there are not more candidates than offices to be elected.

The persons so nominated are:

City Council Member, District 4 - Natasha Johnson  
City Council Member, District 5 - Bob Magee  
City Treasurer - Edwin Castro

That California Elections Code § 10229 allows one of the following courses of action to be taken by the City Council:

1. Appoint to the office the person who has been nominated;
2. Appoint to the office any eligible elector if no one has been nominated; or
3. Hold the election if either no one or only one person has been nominated.

The City Council will hold a special meeting between Monday, August 19, 2024 and Thursday, August 22, 2024 to either make the appointments or direct the election to be held. The persons appointed shall qualify and take office and serve exactly as if elected at a municipal election for the office.

If, by the 75th day before the municipal election, no person has been appointed to the offices pursuant to (1) or (3) above, the election shall be held.

If the City Council makes an appointment pursuant to California Elections Code § 10229, the City Clerk shall not accept for filing any statement of write-in candidacy which is submitted after the appointments are made.
