



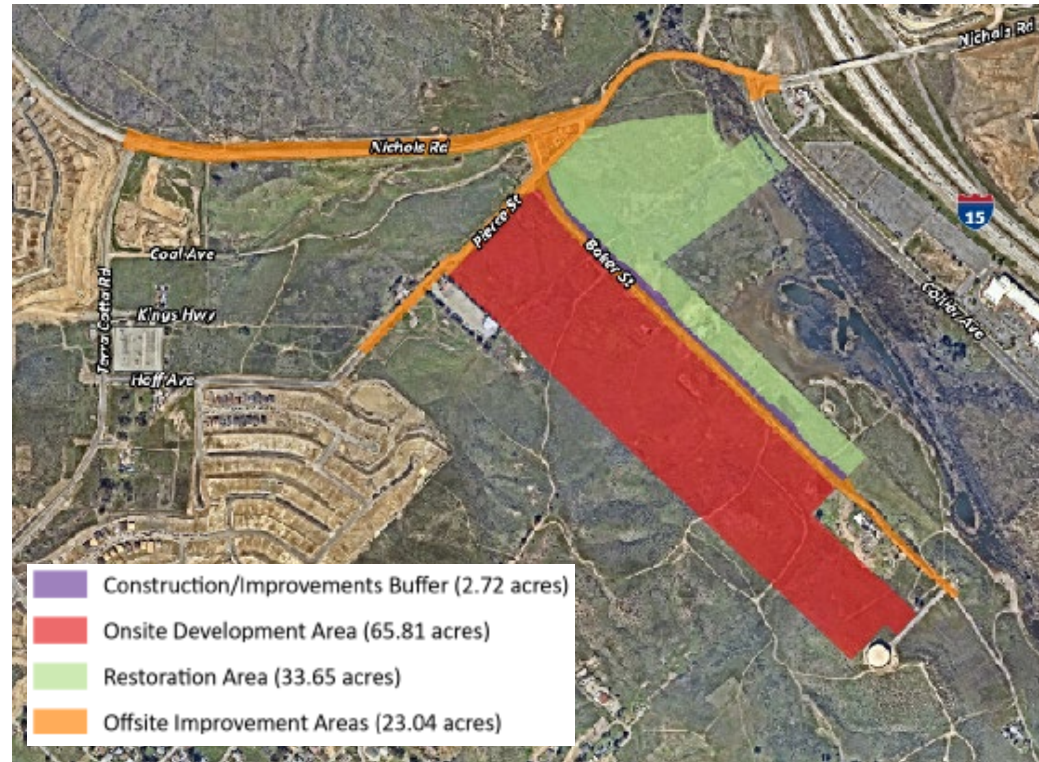

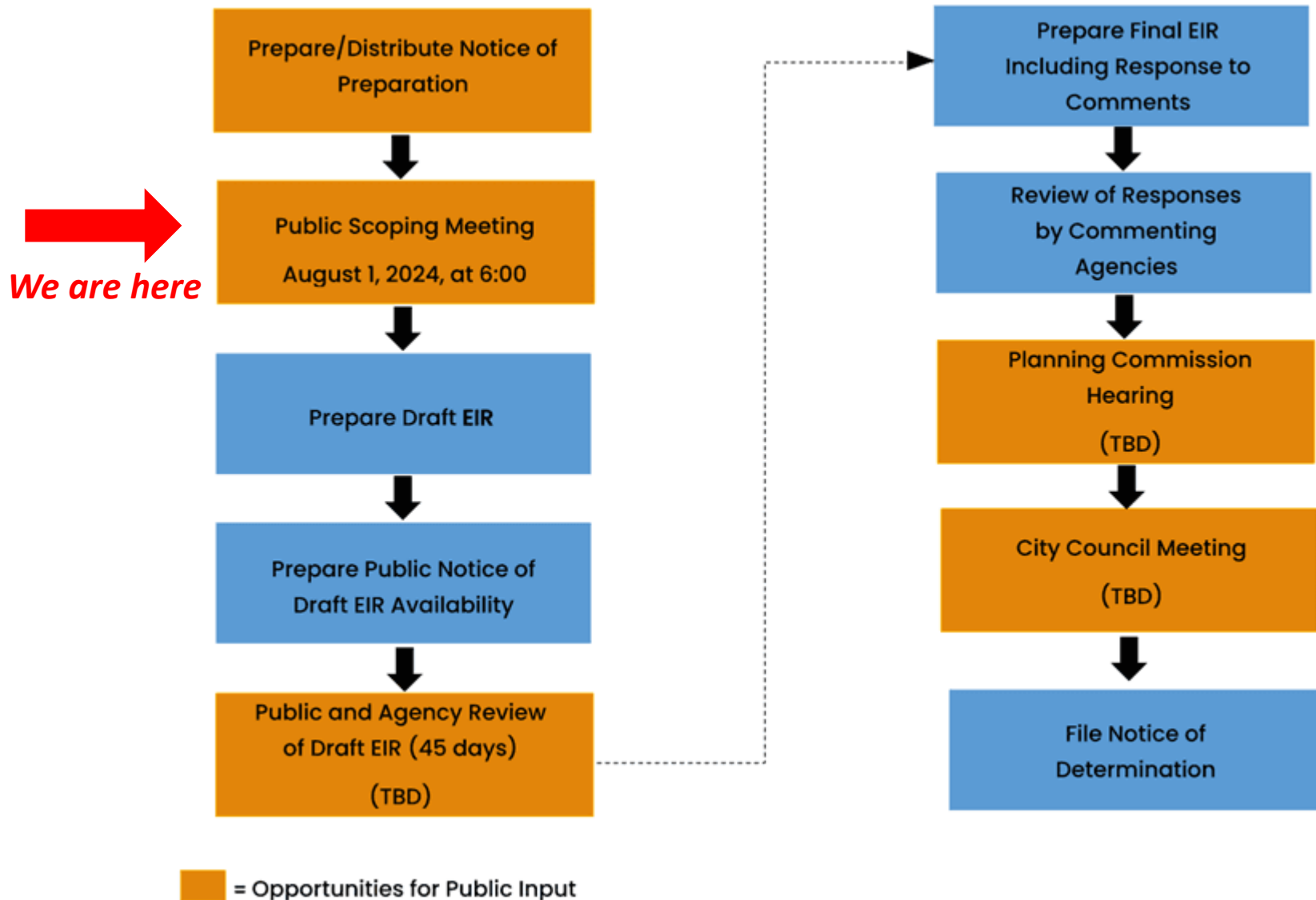

California Environmental Quality Act (CEQA)

What is an Environmental Impact Report (EIR)?

- A public disclosure **document that provides objective information to the public and decision-makers on the potential environmental effects** of the Project.
- **Identify project impacts, appropriate mitigation,** and feasible alternatives to reduce potentially significant impacts.
- **Provide transparency** during the City's decision-making process including **opportunity for public review and comment** on the Project's EIR.
