**QUALIFICATIONS**

Qualifications for appointment to the Planning Commission and Measure Z Citizens Committee are as follows: Members must be at least 18, and cannot be City officers, employees, or under an employment contract. Planning Commission members must either reside in Lake Elsinore or own a licensed business within the city, while Measure Z members must reside in the Council District of the appointing member, unless no qualified candidates are available, in which case the Council member may appoint someone from outside their district. Both are subject to a background check by the Riverside County Sheriff’s Office. For more information, please reference Lake Elsinore Municipal Code Sections 2.24.020, 2.46.030, and 3.30.160 and City Council Policy No. 200-5A or contact the City Clerk’s Office.
