



## SUMMARY OF SURVEY FINDINGS

Nestled against the beautiful Ortega Mountains, the City of Lake Elsinore was founded in 1883, incorporated as a general law city in 1888, and is currently home to an estimated 62,949 residents.<sup>1</sup> With a historic downtown area, multiple parks and recreation amenities, and southern California's largest natural freshwater lake, the City's vision is to be the ultimate destination where residents and visitors can live, work, play, build futures, and fulfill dreams.

Over the past decade, the demands placed upon Lake Elsinore's facilities, services, infrastructure, and staff have grown. Unfortunately, the City's revenue streams have not kept pace with the growing demands and escalating costs, leading to shortfalls in recent years in the funding required to provide essential municipal services at the desired levels of service. The City has been proactive and fiscally responsible in addressing this disparity by cutting back on basic services, deferring maintenance projects, staying efficient, and keeping a small staff despite a growing population. Even with these cost-cutting efforts, however, the City is facing a 2 million dollar deficit next year and will continue to face budget shortfalls in the future unless services are cut further and/or additional revenue sources are realized.

**RESEARCH METHODOLOGY** The City of Lake Elsinore recently commissioned True North Research to conduct a statistically reliable survey of Lake Elsinore voters to measure the community's opinions and priorities as they pertain to city services, and determine if the community is interested in supporting a revenue measure to provide additional funding for these services. Respondents were selected for the study using a stratified and clustered random sampling method, which ensured that the profile of the sample matched the profile of the likely electorate on key variables that are related to voting behavior (i.e. age, gender, partisanship and household party type). The survey was administered using a mixed-mode design, which employed multiple recruiting methods (telephone and email) and provided multiple ways to participate in the survey (telephone and online). During the data collection period (April 23 to April 28, 2019), a total of 888 voters participated in the survey, resulting in a maximum statistical margin of error due to sampling of  $\pm 3.2\%$  at the 95% level of confidence.


**FINDINGS & CONCLUSIONS** The survey results indicate that Lake Elsinore voters are generally pleased with the quality of life in the City, although they have concerns about issues that can negatively impact the City's quality of life including public safety, homelessness, maintenance of streets and infrastructure, and traffic congestion. These sentiments translate into strong support for a revenue measure to provide adequate funding for city services including law enforcement, gang, drug and crime prevention, fire protection, paramedic, and 9-1-1 emergency response services, street maintenance, addressing homelessness, and improving Lake water quality and amenities.

**Quality of Life** As shown in Figure 1 on the next page, approximately half of respondents rated the **quality of life** in Lake Elsinore as excellent (5%) or good (44%), and 41% rated it as fair. Less than 10% of respondents used poor or very poor to describe the quality of life in the City.



**FIGURE 1 QUALITY OF LIFE IN LAKE ELSINORE**




**Most Important Issues** When asked in an open-ended manner to describe the biggest issue facing the community that they would like the City to address (see Figure 2), the most common responses were homeless issues (38%), traffic congestion (21%), public safety/crime/gangs/drugs (21%), and infrastructure maintenance/street and sidewalk repair (18%).

**Support for a Local Revenue Measure** When asked if they would be willing to support a one cent sales tax to provide funding for general city services such as law enforcement, gang, drug and crime prevention, fire protection, paramedic, and 9-1-1 emergency response, fixing streets and potholes, addressing homelessness, and improving Lake water quality and amenities, nearly seven-in-ten voters (69%) indicated they would support the measure, well above the simple majority (50% +1) required for passage.

**Service Priorities** As shown in Figure 4 on the next page, Lake Elsinore voters clearly see a need for the various service, facility, and infrastructure improvements that could be funded by the measure. In fact, all 13 service items tested were favored by at least 8-in-10 voters surveyed. That said, voters were *most* interested in using proceeds from the proposed measure to fix and repair streets (93%), reduce gang activity and drug-related crimes (91%), provide quick responses to 9-1-1 emergencies (91%), keep public areas clean and free of graffiti (90%), and address the homeless problem (89%).
